#### **Contestant Rules:**

Each Eagle Puppy Contestant:

- 1. Can be male or female and at least twenty-one years of age on the day of the contest.
- 2. Must agree to appear onstage wearing appropriate gear and participate in all judged categories while conforming to local regulations pertaining to nudity and obscenity. For the purpose of this contest, genital area must be covered at all times and a minimum one inch strip of material must cover the anus at all times on female pups nipples must be covered.
- 3. Must own all gear worn onstage during the contest.
- 4. Must agree to represent the San Diego Eagle Pup Title, if he/she wins, throughout his/her title year and refrain from competing in any other leather/puppy/rubber/fetish contest until the conclusion of his/her San Diego Eagle Puppy Title.
- 5. Must agree to permit onstage photographs to be taken of him/her for use on the San Diego Eagle Pup & San Diego Leather Pride (SDLP) website or related publications and promotional activities.
- 6. Contestants should arrive at the San Diego Eagle, 3040 North Park Way San Diego California, 92104 no later than 10:00am on Saturday October 19<sup>th</sup>, 2013. (Unless given permission due to special request)

#### **Contestant Deadlines:**

\*\*\*REQUIRED - Deadline for contestant applications for SDEPC is 5:00pm on Wednesday, October 16th, 2013.\*\*\*

Judges should have all applications at least 24 hours before the Interview process.

Contestants should either bring 8 copies of the completed application and one copy of their release and photo identification to the San Diego Eagle registration area promptly at 5:00pm on Wednesday, October 16th, 2013 or drop application off at the San Diego Eagle

prior to Wednesday, October 16th, 2013. You can sign your release at the Contestant Orientation meeting.

#### **Expectations of the winner**

The Winner of the title SDEP 2014 is requested to attend and judge SDEP 2015 contest the following year.

As the Winner of the title, their primary responsibility is to:

Promote San Diego Eagle Pup Contest.

Promote the human Handler/Pup scene.

Produce and Create 1 Outstanding Title Holder Pup Play Event and are highly encouraged to produce several other small events during his/her title year.

Host at least three Eagle Puppy Night Events or Co-Host.

Have fundraisers to raise monies for travel fund and next year SDEPC.

The Winner is encouraged to appear at other leather, Handler/Puppy, rubber/latex and fetish events during his/her title year. He/she should use his/her best judgment as to which events will benefit him/her and his/her title the most.

SDEP 2014 should maintain regular and frequent contact with The Eagle Pup Night Host/ Producer to assist in planning and promotion and to provide regular updates on Facebook, Twitter, Tumblr and any forms of social media.

#### **Prize Package**

The prize package for winners is different each year and depends on donations from vendors and supporters of the San Diego Eagle Pup Contest. The preliminary prize package will be listed on Facebook and website in the weeks prior to the contest, but will not be finalized until shortly before the contest. **Any** monetary prize awarded to The San Diego Eagle Pup titleholder will be awarded in two (2) installments. The first installment is made following the Victory Brunch and consists of half of the monetary prize. The second installment is awarded upon successful completion of the title year.

All Contestants will assemble for final preparations and contest.

#### **Interpreters**

If you do not verbally speak or understand English, bring an interpreter with you and they must attend all official events and rehearsals along with you. The San Diego Eagle does not have the ability to provide interpreters for all contestants in need. Please contact Dayton O'Conner prior to October 1, 2013 for possible assistance if needed. Your interpreter will be given a badge that authorizes them to be with you at all times. Bring your interpreter with you to the weekend registration to receive their Interpreter badge.

#### **Backstage Assistant**

Contestants are permitted one backstage assistant to assist in wardrobe changes for both portions of the contest. Contestants with interpreters are allowed one additional backstage assistant, only if their interpreter is not assisting with wardrobe changes. Backstage assistants are required to be present for pre-contest rehearsal and walk through. Backstage space is limited.

Contestants must notify one of the producers of their backstage assistant at the Friday evening contestant meeting. The producers will arrange a badge for the backstage assistant.

#### Fraternization with the Judges

San Diego Eagle Pup 2014 contestants are encouraged to get to know the judges and interact with them. However, contestants shall be prohibited from having private meetings or engage in any sexual activity or scene play with the judges prior to the announcement of the contest results.

To avoid accidental violation of this policy, and possible removal from the contest, all contestants and judges should display their identification badges at all times.

**Contest Judging Method** 

A panel of five (5) judges representing leaders in the community.

Judging is made in five (5) categories using a combined Olympic scoring system in the categories and points outlined below:

Interview - (maximum 1000 points, up to 200 points per judge, Olympic scoring)

Each contestant will meet with the judging panel offstage and in private, prior to the second portion of the contest to answer questions about the contestant's interest in human puppies, fetishes, knowledge, willingness and ability to represent the title. Interviews will last no longer than 10 minutes each, therefore it is important to listen to the question being asked by the judges and respond in a concise and complete manner so that all judges have a chance to ask questions of the contestant. If the judges would like to know more, they will ask for additional information. Contestants should shake the judges hands upon entering and leaving the Interview.

#### Image - (maximum 500 points, up to 100 points per judge, Olympic scoring)

Each contestant will appear onstage and be introduced to the audience by the emcee using information provided on the completed contestant application. Judging in this category is based on how you present yourself as a "Human Pup".

#### Pup Scene - (maximum 500 points, up to 100 points per judge, Olympic scoring)

Each contestant will appear onstage while a fantasy they have written is read by the emcee. Judging in this category is based on the contestants' creativity and ability to covey their most playful pup scene. Contestants may involve additional Handlers, Pups or helpers once they enter the stage. Props may be used but must be approved by the contest producers for safety. (NOTE: The fantasy is to be typed and a maximum 150 words and turned in at Friday evening contestant meeting.)

Onstage Question - (maximum 500 points, up to 100 points per judge, Olympic scoring)

Each contestant will answer a question onstage. Judging in this category is based on how well you can command the audience's attention as well as how well you respond to the question.

Mosh Pit - (maximum 500 points, up to 100 points per judge, Olympic scoring)

Each contestant will enter the Mosh Pit to select one mystery bag from local San Diego shopping destinations. Inside each bag are several "non-fetish" items, which the contestant must find some creative use for in a fetish scene. Judging in the category is based on a contestant's creativity, knowledge of safe play practices and spontaneity. This is part of the Pup Scene.

The Olympic scoring system - The high and low score for each contestant and in each category, is discarded. The remaining scores are totaled for each contestant. The contestant whose aggregate score is the highest will be declared the winner. The contestant whose scores are second and third highest will be declared the first and second runner-up respectively. In the event of a tie under the total scoring system, the dropped high and low scores will be added back into the contestant score in each category.

In the event of any dispute regarding the tallying of the contest, The San Diego Eagle Owner and Mr. San Diego Eagle 2014 shall make the final determination of the winner.

#### **Producer Contestant Suggestions**

The San Diego Eagle Puppy Contest is all about having a good time, socializing with fellow fetish community members and promoting the puppy lifestyle. Contestants are encouraged to participate in leather events and group activities to be seen as an active member of the fetish community.

We try our best to inform contestants of the different events and group meeting as well as social gatherings, there is enough free time to and be seen during the surrounding days prior to weekend and we HIGHLY encourage participation. (Remember Bonus Points)

The San Diego Eagle Pup 2014 Contest was created to have a great time and recognize

the growing interest of Handler/PUP fetish.

We encourage the contestants to have fun and entertain the audience to set this contest apart from many others.

We encourage you to work the audience and judges so that you will stand out on stage. During the contest, contestants are encouraged to demonstrate different puppy looks representing the different judged categories. Time is scheduled during the contest to allow contestants time for gear and look changes. Assistance is available from the Contest Producer staff or by an assistant that each contestant is allowed. Make sure that you come prepared with back up outfits and gear in case accidents or blow-outs happen. Bring your own lube and squeaky toys and remember to clean up after yourself.
